- **261 Little Alum- Raw sewage breakout**

Discussion at length regarding property. Letter was sent to homeowner regarding raw sewage breakout on June 21st, 2022. Due to the imminent health hazard it needs to be replaced. Breakout is happened in of front the property and 50ft from stream. Homeowner said Civil Engineering will be drawing up plans and repair hasn't been done . The board recommended system be pumped regularly until system is fixed. Homeowner stated that he has been getting it pumped and that he will bring the records to the Board of Health office Monday. Health agent felt using the past soil testing was ok to help move along quickly due to the health hazard. Health Agent asked to have plans in by the Sept 30th, 2022. So she has time to review prior to the meeting on Oct 4th, 2022 for review. T. Wood made a motion homeowner at 261 little alum that he will get his finance and plans for next meeting Oct 4th. - **22 Echo- Title Five Component**

Title 5 report came in area of sewer pipe didn't have baffle on the cover. R. Cox has fixed the components. Homeowner will not pay the installer until the as built and COC is in hand and the Installer will not sign until payment is made. This is a civil issue for the two parties and the board will not be involved. When the Health Agent reviewed the file she found that the prior Health agent had signed a COC on the property for inspection with notes of leach field and D box only, elevations set correctly and ties to tank and d-box will be done after foundation is set in place. Designer takes notes of final inspection and health agent was fine if we could get that showing inspection but designer had health issues. Certification from both designer and Installer will be needed before health agent will sign the as built and COC. Board didn't need to vote with the conditionally passes due to it doesn't meet title 5 requirements. Health Agent will look into the COC that wasn't completed.
